Fund Accounting

- NAV calculation: Calculate net asset values and capital account balances;
- Independent validation: Independently validate portfolio values in accordance with valuation policies;
- Reconciliation: Reconcile cash and positions;
- Fee calculations: Calculate management fees, performance fees, equalisation adjustments and incentive fee allocations;
- **Reporting:** Provide secure web-based access to portfolio and general ledger reporting through customised dashboards; and
- Financial statements: Prepare financial statements, including relevant note disclosures under IFRS or GAAP accounting standards and assist in the audit process by providing relevant accounting records and supporting schedules.

- **Due diligence:** Perform investor due diligence in accordance with applicable jurisdictional anti-money laundering legislation;

- **Banking:** Open and operate accounts in required currencies to receive subscriptions and pay redemptions, fees and other amounts as required;
- Transaction processing: Process subscriptions, redemptions, transfers and distributions;
- **Reporting:** Provide secure, online access to investor reporting including contract notes, statements, notices and other ancillary documents and correspondence; and
- Investor liaison: Provide timely responses to ad hoc inquiries from investors and their authorised representatives.

Trade Processing

- **Trade processing:** Process subscriptions and redemptions for investments in underlying funds, in accordance with the terms of the offering documents and any applicable side letters;
- **Trade workflow:** Provide automated workflow management through the investment cycle and tracking trade status from initiation through to final trade confirmation and cash transfer;
- **Reconciliation:** Reconcile trades and portfolio positions to trade confirmations, contract notes and statements;
- Data warehouse: Maintain a comprehensive data warehouse of key terms and documents for underlying funds; and
- Valuation: Obtain warehouse pricing from independent third party pricing sources for all underlying funds.

PORTFOLIO ANALYTICS AND REPORTING


Intuitive and contextualised portfolio insight

Investors and managers are demanding greater transparency and intuitive risk and performance reporting. The Maples Group fund services team delivers comprehensive and specific reporting that captures key metrics accurately in a clear and insightful manner. Data is captured from our accounting and data management systems, as well as from external parties (e.g. custodians, administrators and counterparties).

We provide meaningful and sophisticated reporting on performance and risk analytics, including:

• Assets overview: Flexible reporting for monitoring exposures by counterparty, currency, market sector, etc.;

- **Position-level detail:** Granular breakdown of assets with post trade compliance tools;
- **Cash:** Reporting of cash balances by currency, as well as tools for cash forecasting;
- **Performance:** Customisable performance calculations across time horizons and performance comparisons against pre-defined or custom benchmarks;
- **Risk:** Reporting of standard deviation, risk adjusted returns, value at risk, what-if scenarios, factor analysis and correlation analysis at multiple levels of abstraction (e.g. fund level, asset class level, strategy level, etc.); and
- Specific views of asset classes: Custom views for asset classes which capture the nuances of each instrument type.
