- Prepare and sign secretarial certificates and other documents as company secretary;
- Maintain the statutory minute books and registers;
- Certify copies of corporate documents maintained on the minute book;
- Manage changes in share capital and share structures;
- Maintain the company seal;
- Prepare and submit filings to the Companies Registration Office and the Central Bank of Ireland<sup>3</sup>;
- Prepare director and shareholder written resolutions; and
- Provide compliance alerts and attend to all ACRA filings in a timely fashion<sup>2</sup>.

## Corporate Services

- Provide company incorporation and limited partnership registration services;
- Arrange the execution, notarisation and apostilling of documents;
- Assist with shareholder meetings;
- Prepare articles of incorporation;
- Schedule and attend meetings in front of a notary for an incorporation;
- Update the Luxembourg Trade and Companies Register<sup>1</sup>;
- Request certificate to the Luxembourg Trade and Companies Register<sup>1</sup>; and
- Assist with official translation<sup>1</sup>.

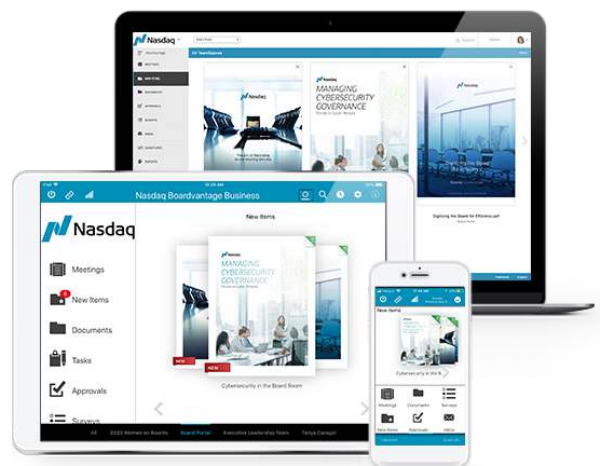

- Configurable retention settings to align with corporate governance policies.

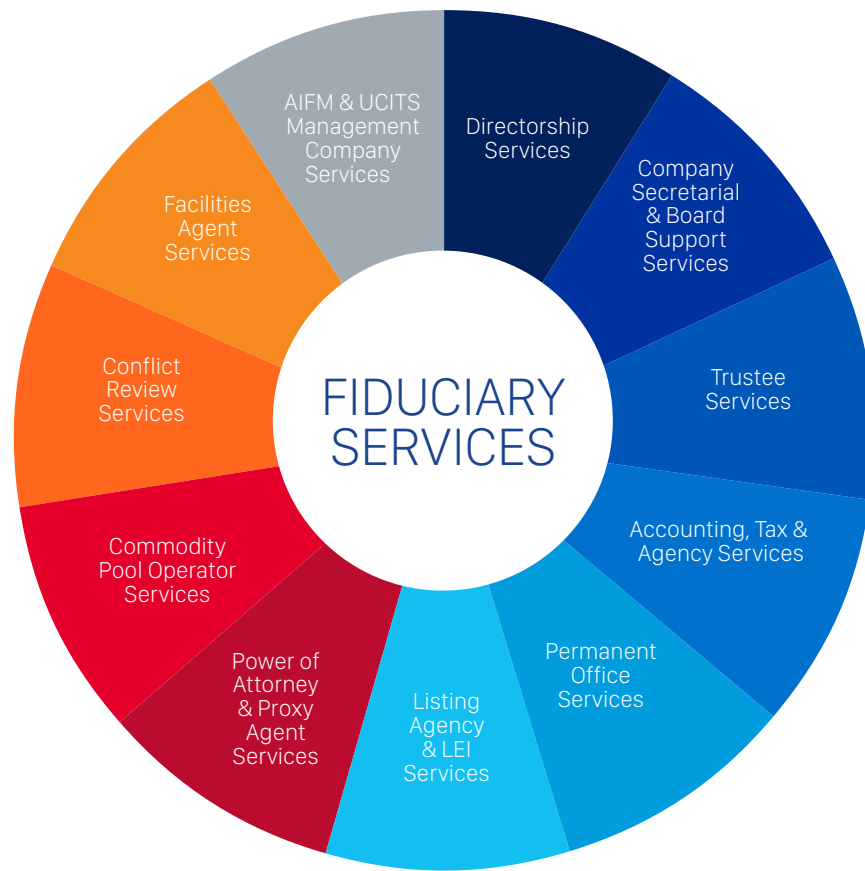
